

## CODE OF CONDUCT AND ETHICS

### Standard Bank Private International Pairs South African Final

Golf is a sport that requires high standards of behaviour and sportsmanship and relies heavily on honesty, integrity, and self-regulation. ASM believes strongly that its participants should strive to set an example to their peers and should always show the utmost respect towards themselves, fellow participants, staff and the host clubs, host countries and clubs that they represent.

Having qualified to participate is a privilege which comes with responsibility and is available only to a select few; participants are therefore expected to bear this in mind when considering their approach both on and off the golf course.

**The following conduct, among others, both on and off the course will not be acceptable or tolerated at any time:**

1. The abuse of alcohol.
2. Partaking in the use or distribution of drugs.
3. The use of offensive language whilst at a tournament organized by ASM.
4. Presenting oneself in a manner, which may cause negative comment in one's personal presentation, ASM, STANDARD BANK PRIVATE, INTERNATIONAL PAIRS and the SPONSORS.
5. The throwing of clubs or the abuse of golfing equipment.
6. Conduct, which may offend the etiquette or the rules of golf.
7. The standards of fair play, sportsmanship and the etiquette of golf are properly and always maintained.
8. Acknowledge diversity and respect other cultures and beliefs.
9. Acknowledge the protocol of the Sponsors.
10. Failure to enter your score within the set HNA/SAGA/GOLFRSA perimeters (24hrs), after any STANDARD BANK PRIVATE INTERNATIONAL PAIRS SA event, will result in your disqualification from the next leg you might have qualified for.
11. Any damage to property caused will be recovered from the participant.

**Standard Bank Private International Pairs / African Sports Management will not be held accountable for the following pre, during and after the South African Final of the Standard Bank Private International Pairs Event:**

- Loss of personal items.
- Injury or harm to self and others.
- Any personal outstanding accounts, credits while at the event, at the hotels or courses.

- Any medical or hospital bills and accounts.
- Any fees that might incur due to breakage, damage or loss of hotel, golf course, and organizers equipment.
- Any lawless activities and implications that follow.
- Cancellation of travel due to any reason and the fees that might incur.
- Loss of baggage.

**A participant found guilty of these transgressions will be asked to leave the Tournament immediately.**

**All costs incurred by ASM and the Sponsors on the participant and his/her partner will be recovered from the transgressing participant. There could be other sanctions to the transgressing participant.**

**Photographs.** By entering the tournament, players hereby grant the tournament organizers and media parties involved the irrevocable right and permission to photograph or videotape (or to use any similar medium) to record yourself and others involved identified below, for all purposes, including advertising and promotional purposes, in any manner without any further approval and without payment. By entering the tournament players understand that any and all photographs, motion pictures, video recordings, and/or likenesses captured during any Airtime Activity, its affiliated entities or contractors, and/or the media become the sole property of the tournament organizers and media parties involved. Players hereby grant the right, permission and authority to tournament organizers and media parties to use and license others to use your name and any such photographs, motion pictures, recordings, and/or likenesses (the "Recordings") in any manner. The Tournament Organizers and media involved wishes and in any and all media now known or hereafter discovered or developed, in perpetuity, without geographical limitation, including but not limited to promoting, advertising, and marketing activities. Players further understand that the tournament organizers and media, as sole owner of the Recordings, has the full right to sell and/or profit from the commercial use of such Recordings or to transfer or assign the rights to use such Recordings to any entity without restriction. Players hereby agree not to sue and irrevocably and unconditionally release, waive and forever discharge the tournament organizers and media Released Parties, together with any commercial television or media company, and their respective past, present and future parents, subsidiaries (whether or not wholly-owned), affiliates, divisions, agents, representatives, employees, successors and assigns, jointly and individually, from any and all manner of liabilities, claims and demands of any kind or nature, whatsoever, in law or equity, whether known or unknown, which I (or my assigns, agents and/or representatives) ever had, now has, or in the future may have against the tournament organizers and media Released Parties.
